**4. FIRST AID MEASURES****First aid measures****General advice**

Immediate medical attention is required.

**Eye contact**

Flush immediately with water for 15 minutes. Lift upper and lower eyelids for complete rinsing. Get immediate medical attention.

**Skin Contact**

Flush with water for 15 minutes. Get medical attention. Remove contaminated clothing and wash before reuse.

**Inhalation**

Remove victim from immediate source of exposure to fresh air. If breathing is difficult, administer oxygen if available. If victim is not breathing, administer CPR. If individual experiences nausea, headache, or dizziness, get immediate medical attention.

**Ingestion**

Rinse mouth with water. Give water to dilute. Do not induce vomiting. Get immediate medical attention. Never give anything by mouth to a semi-comatose, comatose, convulsing or unconscious person.

**Self-protection of the first aider**

Use personal protective equipment as required. Avoid contact with skin, eyes or clothing.

**Most important symptoms and effects, both acute and delayed**

**Symptoms** Corrosive. Causes irritation (possibly severe), burns to the eyes. May cause permanent eye damage. Causes irritation (possibly severe), burns to the skin. Causes irritation (possibly severe), burns, pulmonary edema to the respiratory tract. Causes irritation (possibly severe), burns, nausea, vomiting to the gastrointestinal tract. The severity of effects depend on concentration and how soon after exposure the area is washed.

**Indication of any immediate medical attention and special treatment needed**

**Note to physicians** Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure.

## 5. FIRE-FIGHTING MEASURES

**Suitable extinguishing media**

If the stock solution container breaks, the solution should be handled with care as it is corrosive. Direct contact with water can cause a violent exothermic reaction.

**Protective equipment and precautions for firefighters**

As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear. Use water spray to cool fire exposed containers. Move containers from fire area if you can do it without risk.

## 6. ACCIDENTAL RELEASE MEASURES

**Personal precautions, protective equipment and emergency procedures**

**Personal precautions** Evacuate nonessential personnel. Ventilate area. Wear appropriate personal protection equipment.

**Methods for containment** Absorb spill with inert material (e.g. dry sand or earth), then place in a chemical waste container. Stop leak if you can do it without risk.

**Methods for cleaning up** Recover as much material as possible into containers for disposal or reuse. Remaining material may be diluted with water and neutralized. Flush spill area with water. Neutralization products, both solid and liquid, must be recovered for disposal.

## 7. HANDLING AND STORAGE

**Precautions for safe handling**

**Advice on safe handling** Do not get in eyes, on skin, or clothing. Do not breathe vapors or mists. Do not ingest. Wash thoroughly after handling. Wear protective clothing/equipment. Use with adequate ventilation. NEVER add water to product. ALWAYS add product, with constant stirring, slowly to surface of water to minimize heat generation and spattering.

Keep containers tightly closed and properly labeled. Containers that have been emptied will retain product residue and should be handled as if they were full. Store in a cool, dry, well-ventilated place away from incompatible materials. Wash hands before eating, drinking, using tobacco, applying make-up or using the toilet. Do not store, use, and/or consume foods, beverages, tobacco in areas where this product is stored.
